# Classification report for roof coverings exposed to external fire according to EN 13501-5

#### 1 Introduction

This classification report defines the classification assigned to roof covering "Solar Tiled Roof (STR)" or "Solar Full Roof (SFR)" in accordance with the procedures given in EN 13501-5:2016.

#### 2 Description of the roof covering

#### 2.1 General

The product "Solar Tiled Roof (STR)" or "Solar Full Roof (SFR)" is defined as a roof covering. Its classification is valid for the following end use application: Solar panel.
